Museum Ambassador's Report

2021 is getting away from us quickly, it is hard to believe that we are less than 90 days away from the Holiday Season. The Museum has fared well through all of the trials of the last 18 months and continues to move forward. The NCM just celebrated its 27th anniversary, saw its first expansion program in 2008 and the addition of the Motorsports Park in 2016. Now Plans are in the making for a 30,000 square foot, 2-story annex to the Museum. More specific plans will be announced at the 2022 NCM Bash on April 28, 2022. The Museum has also acquired the old Country Hearth Inn Property and demolition of that property began October 4th. No immediate plans for the property except for added beautification of the NCM Campus.

A continuing special exhibit is the Corvette Powered Exhibit which features non-GM built, mid-century vehicles utilizing Corvette Power Trains. I personally saw this exhibit back in June of this year on a visit to the Museum and it is great! You will immediately recognize a number of very famous vehicles including a Corvette Boat.

2021 Corvette production stats are out. There was a total of 26,216 Corvettes produced with 57.6 percent of them being coupes. Once again, Torch Red was the most popular color appearing on 5,121 units followed by 3,769 Artic White, 3,476 Red Mist and 2,818 Black. The two least popular colors were Accelerate Yellow with 839 and Zeus Bronze with 509. 69.5% of the cars left the factory with the Z-51 suspension, 61.1% had Front Lift and 87.2% had the Performance Exhaust. 361 Corvettes were shipped to Japan and 246 to the middle east. There were 1274 New Corvettes were ordered with the R8C Museum Delivery option in 2021.

Speaking of R8C, the Museum delivered its 14,000th Corvette on July 2, 2021, to John and Gina Engel of Omaha NE. It was their first trip to the museum! How do you top that!!

Things remain busy across the street at the Motorsports Park also. There are two Corvette Experience days on schedule for the month of October. They are October 8, and October 15. Get classroom instruction and behind the wheel experience in a C8 Corvette on the 3.2-mile, 23 turn, road course. The Experience is all-day and the cost is \$799.00.

My report is never complete without putting in a plug for the museum raffles. With wait times as they currently are, winning a raffle may be the quickest way to get a new Corvette. There are 3 remaining raffles in the 2021 calendar year and all are 2022-year models. They are as follows:

- October 21, 2021: 2022 Hypersonic Gray coupe, Ticket Price \$100.00, Maximum tickets to be sold 2,000, tickets remaining as of this writing 109
- November 11, 2021: Build Your Own Corvette or \$70,000.00 in Cash! Ticket Price \$250.00, Maximum tickets to be sold 1,500, Tickets remaining as of this writing 1091
- December 2, 2021: 2022 Silver Flare Convertible, Ticket Price \$200.00, Maximum tickets to be sold 1,500, tickets remaining as of this writing 1,394





Technical Article

Flow to Glow

Unnecessary Operations Points Deducted---Fixed

We all check everything the day or so before operations @ Flight Judging. So, . . . Dash lights work \checkmark ; the 4-way flashers work \checkmark . Thankfully, they all work.

That was in the hot afternoon prior to the judging to take place the next day. However on the morning of the judging, which was much cooler, there were NO dash lights and NO 4-way lights!

EASY FUSE HOLDER FIX

After removing the A/C duct to get to the fuse box, I just touched the fuse with my tester and the lights came on. It was the same with the 4-way flashers.

That resulted in looking at the wiring diagram in the manual. The dash lights and 4-way have their own fuse to each and not shared with anything else.

I was able to fix the corrosion on the holders with a wooden dowel (a little smaller than the diameter of the fuse) and with some 1500-2000 sandpaper.





I cut the dowel the length of a fuse, glued a small piece of sandpaper onto the dowel with the hot glue gun, then cut a piece of dowel approximately 2". Made a "T" with the two pieces, glued them together and went to work.

Eventually a lot of debris was removed from the holders. An air hose blew out the area real good. I added a little Diox to a Q- tip and coated the fresh area of the holder. FIXED!

The corrosion was blocking the flow of current (electrons) so much that the lights did not have enough flow to glow.

Chevrolet Shipping Data Reports from 1965-1972

National Corvette Restorers Society is pleased to announce that we can now provide certain information for model years 1965 through 1972 for Camaro, Chevelle and Nova through the efforts of the NCRS and permission granted by General Motors. We believe our fellow hobbyists and car clubs have desired this information since it became available for Corvettes several years ago.

The information consists of the dealer code, dealer name, dealer location and the production date the car was produced. The good news is this may allow you to find the original dealer where your Chevrolet Camaro, Chevelle or Nova was shipped and possibly open the door to finding more information about your Chevrolet.

A Camaro, Chevelle or Nova Shipping Data Report can be ordered only online. Membership in NCRS is not required. The fee will be \$50 payable by credit card or PayPal. You will receive via USPS a letter with the information which includes the NCRS official seal. In limited cases the dealer code is not available or readable and, in this case, a full refund will be made. www.chevymuscledocs.com
