
Chairman's Report

Vice Chairman and Newsletter Report

- Report given by Jim Krakau
 - Discussion regarding the annual Southeast Chapter Top Flight Award and the requirements for achieving it.
 - There are 8 requirements and 6 variables needed to achieve Chapter Top Flight.
 - Requirements consist of Judging Meets, Judging Schools/Technical Seminars, Membership Annual Meeting, Charitable Event, Road Tour, Social Event, Maintaining a Chapter Website, and Annual IRS Filing Report.

Technical Articles

C5 Cooling System & Fan Operation

Ralph Goode

Overview:

The engine cooling fan system consists of two electrical cooling fans. The fans are controlled by the powertrain control module (PCM) which operates both fans together at low and high speeds. Due to impeller design of the fan blades themselves, the fans are very quiet at low speed. So much that you probably will not hear them over the running engine.

For model years 01-04: The factory thermostat is set at 195°F. When driving at speeds where sufficient air flows across the radiator and the AC off, both cooling fans will be off until the coolant reaches 226°F. The cooling fans start and stop as follows:

1. Both cooling fans are commanded on low speed when the coolant temperature reaches 226°F.
2. Both cooling fans are commanded Off if the coolant temperature lowers to 219°F.
3. Both cooling fans are commanded On high speed when the coolant temperature reaches 235°F.
4. Both fans go to low speed if the coolant temperature lowers to 226°F.
5. When the A/C is on and the coolant temperature reaches 185°F, both cooling fans will be turned on low speed at vehicle speeds of less than 35 mph.

For model years 97-00 operating temperature are slightly different - fans come on low speed at 219 °F, fans come on high speed at 228 °F.

The C5 Corvette was designed with coolant loss protection, where engine power is limited when coolant temperature reaches 256 °F at which time the DIC will display "COOLANT OVER TEMP" and "ENGINE PROTECTION REDUCE ENGINE RPM".

Electrical problems with the fans, or the relays, you will set diagnostic trouble codes.

Detailed Description

The engine cooling fan system consists of two electrical cooling fans and three fan relays. The relays are arranged in a series/parallel configuration that allows the powertrain control module (PCM) to operate both fans together at low or high speeds. The cooling fans and fan relays receive battery positive voltage and ignition 1 voltage from the under hood electrical center. The ground path is provided at G102.

During low-speed operation, the PCM supplies the ground path for the low-speed fan relay through the low-speed cooling fan relay control circuit. This energizes the cooling fan 1 relay coil, closes the relay contacts, and supplies battery positive voltage through the cooling fan motor supply voltage circuit to the left cooling fan. The ground path for the left cooling fan is through the cooling fan 3 relay and the right cooling fan. The result is a series circuit with both fans running at low speed.


During high-speed operation the PCM supplies the ground path for the cooling fan 1 relay through the low-speed cooling fan relay control circuit. After a 3-second delay, the PCM supplies a ground path for the cooling fan 2 relay and the cooling fan 3 relay through the high-speed cooling fan relay control circuit. This energizes the cooling fan 3 relay coil, closes the relay contacts, and provides a ground path for the left cooling fan. At the same time the cooling fan 2 relay coil is energized closing the relay contacts and provides battery positive voltage on the cooling fan motor supply voltage circuit to the right cooling fan. During high speed fan operation, both engine cooling fans have their own ground path. The result is a parallel circuit with both fans running at high speed.

The low-speed cooling fan is commanded on when the coolant temperature reaches 108°C (226°F). It is turned off if the coolant temperature lowers to 104°C (219°F). The high-speed cooling fan is commanded on when the coolant temperature reaches 113°C (235°F). It is turned off if the coolant temperature lowers to 108°C (226°F). When the A/C is on and the coolant temperature reaches 85°C (185°F), the low-speed cooling fan will be turned on at vehicle speeds less than 56 kPh (35 mph).

How to turn on radiator fans at any coolant temperature.

1. Turn on AC in Recirc Mode and increase interior fan speed to max.
OR
 2. Turn Defroster to max temp and increase interior fan speed to max

Pre-Judging the C6



Shifter Release, No park lock

- ▶ If you have had experienced the concern of “No Park Lock on a C6”
- ▶ It is likely the result of a failed park lock solenoid or micro switch issue, or a damaged shifter lock assembly.
- ▶ Online search showed a repair updated harness with NEW micro switches available.
- ▶ I decided to order the new harness just incase it really was the problem before I disassembled the shifter assembly.
- ▶ Following is the procedure I went through for access to the harness assembly.

Shifter Concerns

- ▶ I noted that my Shifter Assembly did not perform as designed when I purchased the vehicle.
- ▶ I did document that the shifter would come out of park with some effort without the brake being depressed. I was able to maneuver the shifter assembly by holding the knob to the far right and demonstrating proper operation to get through OPP's at a Chapter meet.

I was more concerned with what I did not know was wrong so I would address ALL concerns before the Regional.

The car overall scored very well so now I would address the failures mostly focusing on the shifter issue.

New Shifter

- ▶ After the following diagnosis I realized a NEW shifter Assembly would be required to solve the concern.
- ▶ The following are the steps required to complete this repair.
- ▶ As you will see the broken/worn parts in the picture of the old shifter.

Old Shifter Parts: Note: The Harness and the Worn plastic shifter cable bushings. See the Broken park lock tab



First Steps

Start by opening the console

Depending on your options you will have more/less items to disconnect

Remove the 2 screws holding the plate covering the optional accessory cover



Remove the Console lid door

Looking at the hinge, remove the 4 attaching screws. These screws have a tendency to strip out so take your time.




Remove the Shifter Boot

- ▶ To accomplish this, pull the park brake on .
- ▶ Now take the boot and push backwards and up to release the clips holding the boot.




Now remove the SIDE dash trim bolts

- ▶ These are located under the Park Brake boot. Take your time , I dropped 1 of the bolts and required some maneuvering to recover.



Recovered Bolt



Remove Console side Trim

- ▶ Using a forward/down push the trim should release from the console/glove box.



Console Trim

- ▶ To remove trim as an assembly, Pull gently on the outside edges.
- ▶ It is held by clips on the outside edges as you can see in the pictures.
- ▶ The picture shows the clips on the right side and note there are similar clips on the left side.
- ▶ Just take your time, they will release without much effort.
- ▶ Please note you will have to disconnect the electrical harness to the 4-way flasher button, traction control and accessory port plus any optional connections.

Remove Radio/Heater Surround



New shifter Assembly, WARNING

You do not need to remove the shift boot to gain access to the shifter assembly bolts, but you will to replace the harness.

A few bolts will loosen the Shifter assembly.

Lift slowly and unhook the shift indicator as you go. Also DO NOT lift shifter assembly to high, you can run the risk of **dislodging** the lower shifter cable guide to the shifter. If this occurs you might have to drop the underside torque shaft panel to reattach.(not good)

I did replace my harness assembly with the upgraded version before installing my new shifter to eliminate possible future concerns.


